Request for a policy to be added to School Docs around Designated Caregivers that would support our current Residential Caregivers policy, which Nicki feels is not specific enough and does not quite meet the requirements of the Code of Practice.

Nicki reviewed this policy recently as she had a request for a Designated Caregiver, however they did not meet the requirements. Our Residential Caregivers policy is not specific enough. Sieba put out guidance to schools late last year around this, as there has been a rise in requests for Designated Caregivers that don't meet the very specific criteria.
