Fees notes:

Tuition

Tuition includes orientation, academic support, class tuition, ELL (English Language) classes, textbooks, school magazine, curriculum-based class trips, government levies and taxes.

An alternative programme for 4 weeks in Term 4 for any Year 11, 12 or 13 international students not taking NCEA exams.

Short term enrolments are by arrangement and subject to class availability.

Special medical or learning support is not included in tuition and will be invoiced separately.

Homestay

All international students are required to stay in a school provided homestay, unless they are living with a parent or Designated Caregiver (DCG) – an immediate family member or close friend – arranged at time of application.

The homestay fee includes three meals a day, a furnished room and WIFI. Specific dietary requirements may incur additional charges by arrangement.

A fee of \$250.00 may apply to students who change homestays at their request.

Administration Fee

Non-refundable fee to cover administrative costs.

Insurance:

All international students are required to have comprehensive travel and medical insurance. Our default provider is Uni-Care. Students may provide their own insurance, but it must meet the conditions of The Education (Pastoral Care of Tertiary and International Learners) Code of Practice 2021, and an English version of the policy must be provided to school.

National Certificate of Educational Achievement (NCEA)

The New Zealand Qualifications Authority charges international students \$383.30 for NCEA. Short-term students are not required to enter for NCEA.

Airport Pick Up and Drop Off

Students are met at Christchurch Airport by the International Director, a staff member or their homestay. This fee includes one pick up and one drop off per year. Additional charges may apply, for pick up or drop off on weekends or public holidays.

Uniform:

All students are required to wear uniform.

For a returning student the uniform charge reduces to \$400 per year.

Rental uniform for short term students may be available, on enquiry.

Activities Fee

This covers all additional course costs, activities, trips and general expenses. **Monies not used will be refunded.**

Room holding Fee

\$50 per week. This fee is for returning students, who leave their belongings in their homestay, when they return home during holiday periods.

Personal Expenses

The student is expected to pay for personal expenditure including public transport, cell phone plans, additional food/snacks, personal clothing, holiday activities, correspondence, or additional tutors.

Refunds

Refunds up to the beginning of the course are payable in full except for the administration fee of \$800.00 and the Homestay Placement Fee of \$300.00, (if a student has been placed with a homestay family).

After the course begins, one full term's notice must be given before a refund can be made. Refunds are permitted only for extreme situations of health or family circumstances.

Except in exceptional circumstances, no refund is payable to a student who withdraws in the second half of the course.
